TERMS AND CONDITIONS

- 1. The Show organizers (herein called "Management") will hold The T.O. Grooming Show, at Pawsway, 245 Queens Quay West, Toronto, Ontario on June 11 and 12, 2016.
- 2. Management reserves the right to exercise its sole discretion in the acceptance or refusal of applications. Priority will be given to Exhibitor applications according to the order of receipt. In the event of a conflict regarding space or other imperative conditions, Management shall have exclusive right to assign space, rearrange or relocate space to the Exhibitor.
- 3. Conditional upon Pawsway Toronto placing the exhibit space applied for herein at the disposal of Management, the Management shall make the applied space available to the Exhibitor for the period of the Show.
- 4. In the event that (i) the location in which the Show is to be held or is held is destroyed or becomes unavailable for occupancy or (ii) Management is unable to permit the Exhibitor to occupy the facility or the space, or (iii) if the Show is cancelled or curtailed, for any reasons beyond the control of Management, including but not limited to, casualty, explosion, fire, Acts of God, civil disturbances, or strike, Management will not be responsible for any losses or damages of whatever nature that the Exhibitor may suffer.
- 5. Subletting of space by Exhibitor, sharing or other use of the space not specifically authorized by Management is prohibited.
- 6. Exhibitors shall not be entitled to a refund of any part of any fee should the Exhibitor for any reason be unable to exhibit at the Show, or cancel any space previously contracted for less than 30 days prior to June 11, 2016.
- 7. Exhibitors shall observe and abide by additional reasonable regulations made by Management for the efficient or safe operation of the Show. Exhibitors assume all liabilities and/or obligations caused by faulty or improper displays.
- 8. If an Exhibitor fails to make payments due herein when they are due, such Exhibitors rights to exhibit may be cancelled by Management without further notice. Management has the option to cancel or reassign the exhibit space of any Exhibitor who has not complied with payment terms. Such Exhibitor shall not be entitled to a refund of any part of any fee and shall be responsible for any unpaid balance due. Management shall be entitled to close an exhibit at any time for failure by any Exhibitor or any of their officers, agents, employees or other representatives to perform, meet or observe any term or condition set forth herein, and such Exhibitor shall not be entitled to a refund of any part of any fee.
- 9. Neither the Management, nor any of its officers, agents, employees or other representatives, shall be held accountable or liable for, and the same hereby released from accountability or liability for any damage, loss, harm or injury to the person or any property of the Exhibitor or any of its officers, agents, employees or other representatives, resulting from theft, fire, water, accident or any other cause.
- 10. Exhibitor hereby agrees to indemnify, defend and protect Management against, and hold and save the Management harmless from any and all claims, demands, suits, liability, damages, loss, costs, legal fees and expense of whatever kind or nature which might result from or arise out of any action or failure to act of Exhibitor or any of its officers, agents, employees, or other representatives, including but not limited to claims or damage or loss to property, or from or out of any damage, loss, harm or injury to the person or any property of Exhibitor or any of its officers, agents, employees or other representatives.
- 11. No signs or advertising devices shall be displayed outside of Exhibitor space other than those furnished by Management. Displays preventing the unobstructed view of the Exhibit space are prohibited. No displays or signs may be affixed to building walls or posts.
- 12. Exhibitors agree to staff their booths during all hours that the Show is in progress.
- 13. Any signs or displays erected by Exhibitors shall be of a professional nature. Management reserves the right to refuse inappropriate or unprofessional signs and displays.
- 14. Exhibitors agree to set up their booths during the times allocated for set-up and to be completely set up by time of Show opening.
- 15. Exhibitors bear full responsibility for cleaning the assigned space at end of Show, and shall at all times during the Show keep their display area in a clean and professional condition. Garbage generated by the Exhibitor is the responsibility of Exhibitor and shall be disposed of in a timely fashion.
- 16. Full payment for the Show's space is due at the time of application.


