Space is available for **Winnetka-Northfield Chamber Members** and **Non-Winnetka-Northfield Chamber Members** in three Winnetka commercial business districts: Hubbard Woods, East Elm and West Elm and the business district in Northfield.



During this two day event, the Winnetka-Northfield Chamber pays for additional insurance to receive special use permits from the Village of Winnetka for the use of its sidewalks. All **businesses located within the sidewalk sale areas must pay** the appropriate fees listed in this application or may find the sidewalk space in front of their business assigned to fee-paying vendors. Proceeds from this event will be used to expand the benefits and services provided to chamber members and the community.

Additional details:

- **SWS Sponsorship**: Include your logo on all promotional materials and advertisements. Cost: \$250.
- **Set-Up**: Set-up on Friday and Saturday must be <u>before</u> 8:45 am.
- Spaces Are Not Uniform In Size or Shape. Spaces may have awnings overhead, planters or benches on the ground. Only the Winnetka-Northfield Chamber of Commerce has the sole authority to assign and specify vendor locations. We reserve the right to ask vendors to move or withdraw if they are not in their assigned location or following the allocated contractual space requirements.
- Tents/Umbrellas/Awnings: Most spaces are not conducive to the use of portable tents and awnings. If you plan on using a tent or awning, you will receive special placement in Hubbard Woods Park. Tent spaces will be assigned on a first come, first serve basis.
- **Helium Tanks:** must be pre-approved by the Fire Inspector **and** tightly secured.
- Merchandise & refuse: Vendors must haul away their own refuse and are responsible for any
 merchandise or display pieces left overnight. The Winnetka-Northfield Chamber of Commerce
 does not provide for overnight storage or security.
- Parking: Vendors should park in non-commercial districts or residential districts in order to insure commercial district parking is left open for your customers
- Rain: The Sidewalk Sale will take place, rain or shine. Refunds will NOT be given based on weather.

To assure your place, complete pages 2 and 3 with all fees and return to the Chamber of Commerce office by 6/15/16 to receive the discounted fee. After June 15 the discount will be no longer apply.
