- Intercultural Montessori Language School's hours of operation are from 7:00am to 6:00pm Monday through Friday. Earliest drop-off time is 7:00am. Class begins promptly at 8:30am.
- School will not be open on Holidays, Institute Days and Parent-Teacher Conference Days. Tuition is not based on students' actual attendance nor reduced during holidays or break periods. Please check the annual and monthly calendars for specifics.
- Tuition includes materials and field trips for the academic year.

Discounts: \$1,000 – Sibling Discount for each additional child
1% – Discount of 1% given for full academic year tuition payment on or before August 1st.

Fees: \$100 – A one-time non-refundable fee for new applicants paid at time of initial application per child. (Does not apply to re-enrolling students.)
\$1,000 – A one-time non-refundable registration fee for new applicants per child. (Does not apply to re-enrolling students.)

Tuition Deposit: **A non-refundable advance tuition deposit of 20% is required to hold a student's place in class. This is applied to tuition payments for February 1st & March 1st.

Tuition Payments: Tuition payment due dates are listed in the chart above. All Tuition Payments will be handled by a 3rd party service provider, SMART Tuition, at no extra charge for most payment types. Please keep in mind that credit card users will incur a 2.65% credit card fee from SMART Tuition.

Annual Fund Pledge: We ask for a minimum \$600 pledge per family.

Returned Check Charge: \$25

I / we understand and accept the following terms and conditions of enrollment at Intercultural Montessori Language School:

1. This academic contract is for August 1, 2016 and ends June 8, 2017.
2. Intercultural Montessori Language School offers an eight-week adjustment period to families with a child entering the school for the first time. The adjustment period allows the family and school time to mutually confirm that our Montessori program meets your child's needs. If during the adjustment period, the Executive Director, teacher, or parents believe that Intercultural Montessori Language School does not meet the child's needs, a determination can be made that a child should not continue to attend the school. In this case families are responsible only for the pro-rated tuition and the non-refundable enrollment fees. The Executive Director can make a determination at any time not to have a child continue to attend the school after the eight week adjustment period has elapsed.
3. There is a one-time per child non-refundable \$1,000 registration fee due at the time of initial enrollment. (This does not apply to re-enrolling students.) The enrollment process is not complete until the fee has been paid in full.
4. A non-refundable 20% tuition deposit is also due at the time of enrollment. The deposit will be applied to the installment payments due on February 1 and March 1, 2017. A 20% deposit paid by check directly to Intercultural Montessori is required to secure a student's place.
5. The remaining tuition payments can be made in the following ways:
 - A single payment of the full tuition balance for the academic year paid directly to Intercultural Montessori Language School by August 1, 2016. If the balance is received on or before this date you will receive a 1% early payment discount.

6. Intercultural requires all families, including families that will make one full tuition payment, to enroll with SMART Tuition, a third party service provider, at no additional cost.
 7. I (we) agree to pay the 80% balance:
 - ___ in full on or before August 1, 2016.
 - ___ in 8 installment payments beginning August 1, 2016 through May 1, 2017.
 8. I (we) understand that no tuition adjustments can be made for a child's absence due to illness, vacation, a reduction in school hours by parents, etc.

10. The financial stability of the school depends on timely payment of tuition. I (we) understand that for each payment made after the 10th day of the month, I (we) will be assessed a late payment charge of \$85.00. The charge for a returned check or automatic debit is \$25.00. Payments more than 75 days late are reviewed by the Finance Committee and referred to collection and the child/children may be dismissed from school permanently, effective on the 90th day after the original payment was due. I (we) agree to be responsible for all reasonable costs of collection, including but not limited to attorney's fees and collection agency

cost.

11. Primary students can opt to enroll in either the Half Day or the Full Day program. However, once a student reaches Kindergarten age (5 years old by Sept. 1st, 2016) they are required to enroll in the Full Day program to cover English literacy requirements.
12. On initial enrollment in the school, I (we) have received a copy of the Parent Handbook and agree to abide by the policies and procedures outlined therein, as well as in the various memos that appear throughout the year.
13. I (we) understand that Intercultural Montessori Language School closes for major holidays, three Institute Days per year, Parent/Teacher Conferences, a 2-week Winter Break, a 1-week Spring Break. Adjustments to the monthly calendar take precedence over the annual calendar. Tuition is not based on student's actual attendance or reduced during holidays or break periods.
14. The Annual Fund: The Annual Fund helps us fill the gap between what tuition covers and other requirements or costs associated with the education of our students. These may include operating costs, teacher education, development, and the expansion of the school. We ask for a \$600 Annual Fund pledge per family. Intercultural Montessori Language School needs and appreciates financial help from families. I (we) agree to participate in the school's fundraising activities, including the Annual Fund and other fundraising events announced by the Intercultural Montessori Language School.
15. I (we) agree to attend Parent Education events and meetings that pertain to my child in order to help create a partnership between our family and the school.
16. The school agrees to provide information concerning all field trips or other events not held directly on the school's premises in advance of such occasions. Parents grant permission to participate in such field trips and activities, and accept all risks associated with such field trips and activities. Parents agree that spontaneous walks within 1 mile of the school may not be announced in advance, grant permission for their child to participate, and accept all risks associated with these spontaneous walks.

17. Parents agree to allow Intercultural Montessori Language School to take photos or videos, or to make sound recordings of their children, or to assemble samples of children’s drawings or other work, in order to create promotional materials, articles, reports, or presentations about the work of the school.

18. I (we) agree to provide Intercultural Montessori Language School with all required enrollment forms prior to the student’s first day of attendance. This includes but is not limited to Application for Admission/Re-enrollment Form, Annual Fund Pledge Form, Emergency Contact & Pick Up Authorization Form, Family Questionnaire, Parent Contract, Immunization Form, Vision Form (Kindergarten, all new students), and Dental Form (Kindergarten, 2nd Grade & 6th Grade).

19. This contract may be terminated upon a written sixty (60) day notice by the family. The family is required to pay for the 60-day notice period, and forfeits the non-refundable deposit and enrollment fees whether or not the child is in attendance.
