

2015-16 Chappaqua PTA Membership Form

Why should I join? The Chappaqua PTA provides important, enriching programming for students and parents, and provides its membership with vital communication tools such as the PTA website and email system. Membership is required for your children to participate in the PTA's after school enrichment or theater programs.

How much does membership cost and how do I pay? \$15 per household (\$7.50 per single parent household) for the 2015-16 school year. One household membership covers all children in that household attending all schools in the district. To pay by check, complete the registration form below and mail it, together with your check, to the address indicated. To pay by credit card, visit www.chappaquapta.net after mid-August (note: there is a \$2 online transaction fee.)

In addition to Chappaqua PTA Membership Dues, are there school-specific PTA fees? How do I pay those?

Chappaqua PTA Membership Dues are completely separate from fees that individual schools request.

- Elementary schools collect class fees from each child. These are NOT PTA fees; these are fees used by classroom teachers for extra supplies or activities specific to their classrooms. Your child's classroom teacher or class parent will tell you how much these fees are and how to pay them.
- Bell & Seven Bridges Middle Schools collect PTA Program Fees from each family to fund school-specific PTA programs and activities.*
- Horace Greeley High School collects PTA Program Fees from each student for class-specific activities.*

*To pay Bell, Seven Bridges and/or Horace Greeley Program Fees, visit www.chappaquapta.net for the appropriate school's Payment Form or look for it in the mail. Each school allows payment by check or credit card. Checks for a school's Program Fees must be payable to that school's PTA and NOT to the Chappaqua PTA.
