The National Association of Former United States Attorneys was founded in March 1979. It was established to promote, defend and further the integrity and the preservation of the litigating authority and independence of the office of the United States Attorney as one of the principal instrumentalities through which the President of the United States carries out his constitutional obligation that the laws be faithfully executed. The association also provides a forum for education and continuing professional relationships which have been formed with the Department of Justice and for the exchange of information and professional referrals in the private practice.

An annual conference is held each year which features continuing legal education programs of interest in the areas of federal practice, Department of Justice policies and significant cases. Recent conferences have featured Chief Justice William H. Rehnquist, United States Attorney General Eric Holder, former United States Attorney General Janet Reno, Mayor Rudolf Giuliani, and former FBI Director Robert Mueller.

Membership is open to former Department of Justice officials who have served pursuant to a Presidential commission and persons who have served as a United States Attorney by court appointment or as an acting United States Attorney by designation from the Attorney General of the United States.
