#### The fine print for funeral directors regarding continuing education credits:

For you to register at the Member Rate of \$99 your employer must be a member in good standing of the WCCFA. If you work for a funeral home that is part of a combination cemetery/funeral home firm or is a standalone funeral home member (check with your general manager or call the WCCFA office) funeral directors can register and receive CEU's at the \$99 member-registration rate. If your firm does not meet these qualifications you must pay the non-member price of \$159 to receive continuing education credits. To receive continuing education credits be sure to sign up for them at the conference.

Cemetery, Supplier, Municipal and Associate members register at the member price but do not receive CEUs.
