

Nomination Form Instructions for the 2015 Thirteenth Judicial Circuit Pro Bono Awards Deadline for Submission: February 17, 2015

Created by the Florida Supreme Court, the Thirteenth Judicial Circuit Pro Bono Committee oversees pro bono service to the poor (see Rule 4-6.1, Rules Regulating The Florida Bar) in Hillsborough County. The committee is chaired by Rosemary Armstrong and is administered by the Bay Area Legal Services Volunteer Lawyers Program (BAVLP). Pro bono service in Hillsborough County, whether performed by an individual attorney, or by a law firm or organization, is recognized and promoted as part of our county's HAVE a Heart program.

The Thirteenth Judicial Circuit Pro Bono Awards Ceremony will take place at the Hillsborough County Bar Association (HCBA) Chester H. Ferguson Law Center on April 23, 2015 at 5:00 p.m. Members of the state and federal judiciary will recognize those who have provided outstanding pro bono service in Hillsborough County. Please use the Nomination Form attached to nominate individual attorneys, a law firm, or an organization that made significant contributions of pro bono service to the poor in Hillsborough County during 2014.

Thirteenth Judicial Circuit Pro Bono Service Awards – These awards recognize a Hillsborough County lawyer, law firm, or organization that in 2014 made significant contributions of pro bono legal services to poor individuals, or to charitable organizations whose primary purpose is to provide non-legal assistance to the poor.

The HCBA Jimmy Kynes Pro Bono Service Award – This award recognizes a Hillsborough County attorney who for many years has made significant contributions to ensure legal services are available to persons who otherwise could not afford them. It is dedicated to the memory of Jimmy Kynes, who served as Florida Attorney General and later as General Counsel of the Jim Walter Corporation in Tampa. Following the establishment of the BAVLP in 1982, Mr. Kynes worked with the program to recruit local bar members to provide pro bono assistance. Mr. Kynes' own pro bono service over many years, as well as his recruiting efforts, inspired private attorneys (including corporate counsel from local companies) to interview and advise indigent clients at intake sessions. Mr. Kynes' commitment to the provision of pro bono assistance is reflected by, and continues through, the efforts of the recipients of his award.
