Twenty five years ago the **Americans with Disabilities Act** (known as the ADA) was signed into law by President H. W. Bush with a goal of creating equal opportunities for people with disabilities through inclusion in the workplace, in schools, and in the community. This was neither the beginning nor the end of the long struggle for the civil rights of people with disabilities; however this act did set the pace to begin making a significant impact on the lives of Americans *with* and *without* disabilities.

The *25<sup>th</sup> Anniversary of the ADA* will be celebrated in 2015 across the United States. Here in Cincinnati we will celebrate the silver anniversary on Fountain Square on Monday, July 27, 2015. Festivities will begin with a Disability Pride March starting at Cincinnati City Hall and arriving on Fountain Square at 10:30 to join the main event. Exhibitors will be on hand with information and giveaways; from 11:30 to 1:30 a variety of speakers, entertainers, advocates and officials will take the stage in celebration of the ADA. It is also an opportunity to address the important work still ahead promote equal opportunities for people with disabilities.
