

## Hershey Park Sukkot – Thursday October 1<sup>st</sup> 2015

Dear Parents,

The Silver Academy is planning to participate in Sukkot at Hershey Park on **Thursday October 1<sup>st</sup>, 2015**. Hershey Park will be open that day from 11:00 AM to 7:00 PM; the school will participate from 11:00 AM to 3:45 PM. We want our students and their families to have the opportunity to interact with other Jewish families from surrounding communities and states and to experience Jewish life through music, food and entertainment.

The price of a ticket is **\$42** and includes the following:

- Rides (water rides will NOT be operational)
- Live musical entertainment
- Large Sukkahs that seat over 1,000 people
- A brown bag lunch will be available for **students**. Glatt Kosher catering by Central PA's Kosher Mart will also have food for sale (menu and pricing is online).

**SINCE THIS IS A PRIVATE EVENT, SEASON PASSES CANNOT BE USED**

On the day of the event, school will start at the regular time.

**ALL students who are participating MUST ride the bus from the school to Hershey Park.**

Options for student participation in this event are as follows:

1. Your child/ren can spend the day in Hershey with his/her class and return to the school for parent pick-up at **5:00 PM** – we will keep you posted about our exact time if there is traffic.
2. Your child/ren can spend the entire day at Hershey with his/her family. You **MUST** meet our group at the **OUTSIDE SUKKAH** at **10:45 AM**.
3. Your child/ren can be with his/her class until **3:45 PM** and then spend the rest of the afternoon in the Park with his/her family. You **MUST** be at the park exit no later than **3:45 PM** to meet your child/ren. Students will **NOT** be released to anyone other than a parent/guardian unless there has been a prior written arrangement to do so. If no one arrives to meet the student at **3:45 PM**, the student will return to the school on the bus.

We will likely need assistance to chaperone students who will be in the care of the school for this event. If you would like to assist please indicate that on the form. Chaperones will receive more details closer to the actual event.

Please complete the attached sheet and return it with your payment to the school **no later than Friday September 11<sup>th</sup>** so we can plan appropriately. Unfortunately, no tickets will be ordered without payment. The logistics for this day are quite complex; your assistance and adherence to timelines is critical.
