2015 FOUR CORNERS FEDERAL LANDS INTERNSHIP PROGRAM (FC-FLIP) POSITIONS

San Juan National Forest, Pagosa District - Forest Vegetation Intern

As a Forest Vegetation Intern, you will participate in wide variety of forestry tasks. Primarily these tasks focus on assisting with forestry technicians with the establishment of Common Stand Examination plots and assisting with data entry into a common database.

Springs and Seeps Inventory and Database Intern

Partner with the Mountain Studies Institute and the Springs Stewardship Institute (SSI), of the Museum of Northern Arizona to map springs and springs-dependent species, and to improve understanding of climate change risks to springs in the Colorado River Basin within the Southern Rockies Landscape Conservation Cooperative (SRLCC) region.

San Juan National Forest, Columbine District - District Ranger Intern

The District Ranger Intern will primarily work on range management issues and monitoring. This internship will experience the many facets and complexities of the daily management of a USFS national forest Ranger District.

San Juan National Forest, Dorlores District - Visitor Information Intern

The Visitor Information Intern will assist with public interaction by working the front desk of the Dolores Public Lands Office. The intern will also participate in the developed recreation program by assisting with the general maintenance and upkeep of developed recreation sites.

BLM Tres Rios Field Office - Administration Intern

This internship is a unique opportunity to experience the management and analysis of a multi-million dollar budget.
