STATE LOAN REPAYMENT PROGRAM

SLRP awardee numbers increase in 2015. The California State Loan Repayment Program's (SLRP) 61 awardees for 2015 represent seven disciplines of healthcare professionals, across 22 of California's counties – that's a 38% increase in total providers, 40% increase in represented disciplines, and a 20% increase in counties served!

SONG-BROWN PROGRAM

Song Brown applications are due March 10, 2015. The Request for Application (RFA) for New Slots (\$4M) funding is currently open and available until March 10, 2015. One-time state funding of \$4 million is available to support new primary care residency slots. Eligible residency programs are: Family Medicine, Internal Medicine, Obstetrics and Gynecology (OB/GYN) and Pediatrics. Applications are due March 10, 2015.

The RFA for Primary Care Residency (PCR) funding is also open and available until March 10, 2015. Funding is available to support new and existing resident positions for Internal Medicine, OB/GYN, and Pediatric residency programs.

HEALTH RESOURCES AND SERVICE ADMINISTRATION

HRSA PCTE award applications due February 18, 2015. The Primary Care Training and Enhancement (PCTE) grant proposes to strengthen the primary care workforce by supporting enhanced training for future primary care. In Fiscal Year (FY) 2015, applicants for the PCTE program must focus on training for transforming healthcare systems, particularly enhancing the clinical training experience of trainees.

Some of the characteristics identified by the Centers for Medicare and Medicaid to be closely associated with transformed healthcare delivery systems include:

- Providers across the care continuum participate in integrated or virtually integrated delivery models.
- Care is coordinated across all providers and settings;
- There is a high level of patient engagement and quantifiable results on patient experience.
- Providers leverage the use of health information technology to improve quality.

Eligible applicants include accredited public or nonprofit private hospital, school of medicine or osteopathic medicine, academically affiliated physician assistant training program, or a public or private nonprofit entity. A total of \$9,000,000.00 is available for this program which can fund up to thirty (30) awards. Applications are due by February 18, 2015.

HRSA Nurse Faculty Loan Program applications due February 25, 2015. The Nurse Faculty Loan Program (NFLP) proposes to increase the number of qualified nursing faculty with the NFLP by providing funding to schools of nursing to support the establishment and operation of a distinct, interest-bearing NFLP loan fund. Participating schools of nursing make loans from the fund to assist registered nurses in completing their graduate education to become qualified nurse faculty. The program offers loan cancellation of up to 85 percent for borrowers that graduate and serve as full-time nursing faculty for the prescribed period of time. Eligible applicants include accredited schools of nursing which offer educator coursework within an advanced education nursing degree program(s) that will prepare the graduate student to teach. A total of \$22.5 million is available for this program which can fund up to one-hundred five (105) awards. Applications are due by February 25, 2015.

NHSC Loan Repayment Program application cycle open. The 2015 National Health Service Corps (NHSC) Loan Repayment Program Application Cycle is Now Open and Will Close on March 30, 2015 at 7:30 PM EST.

This Program provides loan repayment assistance to licensed primary care medical, dental, and mental and behavioral health providers who serve in communities with limited access to health care. There are both full-time and half-time service options.

The 2015 application cycle is expected to be competitive. On average, it can take up to three weeks to complete an application so applicants are encouraged to apply early. This year the process may improve for applicants, now that some loan information can be automatically populated by the National Student Loan Data System.

NHSC Scholarship application is expected to open in March 2015. The National Health Service Corps You can apply to the Scholarship Program if you are committed to primary care and accepted to or enrolled in a fully accredited training program for

- Physicians (MD or DO)
- Dentists
- Nurse Practitioners
- Certified Nurse-Midwives
- Physician Assistants

The scholarship pays tuition, fees, other educational costs, and provides a living stipend in return for a commitment to work at least 2 years at an approved outpatient facility in a medically underserved community.
