PRESIDENT'S NOTES

Last week the Mayor and city council directed their attorneys to seek obtaining another stipulation from the active city workers in hopes that they would agree to postpone the implementation of the remaining portions of measure B until January, 2017. This delay would also include Retiree health care. Needless to say the Active unions were not in favor of this proposal . After agreeing to postpone the implementation of measure B several times in the past, the actives strongly turned down the city's offer.

The POA Attorney responded on behalf of all city unions letting the city officials know in no uncertain terms that the issues surrounding measure B and the on-going litigation must be resolved in 2015. So now the ball is in the city's court.

Our main interest in the issue is Retiree health care and the potential impact to our COLA. Recall, that measure B allows for the temporary suspension or reduction of retiree's COLA for up to 5 years (only if the Council finds a "Fiscal Emergency") and it defines the City's "lowest cost plan" as any plan available to to any employee in the city (no matter how few employees are eligible for the plan).

Retiree health care is the issue that has impacted us most. We are kind of in a position of collateral damage given that the active employees decide what the contract will be, or worse in recent years, the City imposes contract terms on the unions and non-represented employees. It is comforting to know that the POA and Local230 are aware of the realization that the retiree health care issues affect us who are retired today but tomorrow it will affect them, so they will do their very best to obtain the best they can get. And they are not willing to buckle to the City's political need to "kick the can down the road" as politicians have so fondly become accustomed to saying


It appears that they are now becoming increasingly aware that the illegality of their precious measure B may become a stumbling block for their political aspirations, and as such want to push off facing the issue as long as possible.


Postponing implementation would also give the appearance of an effort to stem the bleeding of fleeing Police Officers and the skilled city employees.



RESULTS ARE IN FOR THE ON-LINE MEMBER SURVEY



Last month we sent out an on-line survey to our members requesting feedback in several areas. Over 400 of you participated, an overwhelming response. Much of the survey focused on topics regarding communication and communication techniques the Association can use to keep you informed. We asked about what areas you'd like to see covered in the newsletter and what importance they are to you. Nearly 80% of our members stated that updates on the Retirement Fund performance was either their 1st or 2nd priority, while ver 74% stated that receiving updates on major developments in the Police & Fire Departments were their top 2 priorities. Additionally, 74% stated that issues affecting City Hall was of utmost importance. We try and cover these issues on a consistent basis, but will continue to work hard in keeping you apprised in those areas as time goes on.

We also looked at just how active our members are in using social networking tools such as Facebook or Twitter. While we have a very active membership in terms of e-mail and web usage, only 37% of you stated they used social networking sites. The biggest barrier to using social networking? No, not understanding the technology. Only 2.5% stated that knowledge was their barrier. Rather, it was lack of interest. Over 85% of our members who do not already use social networking sites stated that they had no interest in using social networking. All of this was good information to know. So, while we may ramp up our social networking activity in some cases, we will definitely continue to use this newsletter and email to deliver the most important messages.
