At the conclusion of Moyer's public service in January 2015, the department supervised more than 215 Pennsylvania state-chartered banks, credit unions and trust companies; licensed and registered approximately 220,000 financial services professionals and companies that provide consumer loans, investment services and other financial services; and reviewed the submission of more than 5,000 securities offerings annually.

During that period, he served as President, Chief Executive Officer and Director of The Elverson National Bank and National Penn Bancshares, Inc.

Mr. Moyer was born and raised in the Boyertown area of southeastern Pennsylvania. He is a 1973 graduate of Penn State University, where he earned a bachelor's degree in secondary education. He also earned master's degrees in education from Eastern New Mexico University and business administration from St. Joseph's University in Philadelphia. Following graduation from Penn State, he served as an officer in the U.S. Air Force, stationed at Cannon Air Force Base in New Mexico.
