1st-year Indiana University MBA student, Kyle DeLapp, was honored in the St. Jude Children's Research Hospital 's Walk-A-Thon in Atlanta with corporate leaders and a St. Jude patient and his family. Kyle was invited by St. Jude to participate in the Hospital's Local "Heroes" Program because of a water rescue he was involved in several years ago in rough seas in the Gulf of Mexico. Kyle who started his swimming instruction at Echo in the late 1980s, was awarded a Carnegie Hero Award along with two other friends from Roswell, GA after saving four kids who were pulled out to sea by rip tides. After introduction of the Heroes before 2,500 walkers, Kyle and the other heroes pictured walked with the walkers letting the walkers know that it was the walkers that day that were the heroes for supporting the sick kids at St. Jude. Families never receive a bill from St. Jude. Treatments would cost on average \$250k to \$350k a year, but families pay for absolutely nothing for medical treatments, travel, lodging and even food.

Kyle was also recently honored at IU receiving by unanimous vote from his peers, professors and staff, the "Professionalism Award," one of four core values touted by the school's MBA program.

Various members of the DeLapp family have attended Camp Echo in the 1960s, 1970s and 1980s. Kyle's Dad Joe and his Uncle Greg were staffers as well as boys and family campers.
